

## **Montgomery County Solid Waste District Community Cleanup Program**

### **Purpose**

*Offer free haul and disposal to communities and individuals of need in Montgomery County in an effort to clean up illegal dump sites or other areas that have debris and/or solid waste accumulated. Waste Management (WM) will provide containers, hauling and disposal for up to 1,000 tons of municipal solid waste disposal. The program will cease after the allotted 1,000 tons of disposal has been used.*

### **Program & Restrictions**

*This program covers (at no charge) delivery and pick up of a solid waste container (typically 20 yard or 30 yard roll off) for a period of time not to exceed 10 business days. The cost to dispose of the solid waste will be at no charge to the recipient. The process to physically place solid waste into the container is the responsibility of the recipient.*

*The recipient must have a suitable, safe and approved/permitted (by landowner, jurisdiction, etc.) location in Montgomery County for the container. The area for container delivery must be easily accessible and must safely accommodate the size of the container. Montgomery County will not be responsible for damage caused by the placement or removal of the container. Delivery and pick up of the container unit can be scheduled for Monday through Friday, between the hours of 6:00am and 5:00pm. It is recommended the container be placed in an area that will not promote the use of unauthorized dumping of solid waste. Montgomery County Solid Waste District/ WM will not be responsible for removal or disposal of solid waste from any other source except the recipient. Montgomery County Solid Waste District and WM will not be responsible for removal or disposal of solid waste outside of the container unit. WM may require the recipient to be present at delivery and pickup to deal with any problems with setting the container.*

*An application must be completed and signed. Applications will be reviewed on a first in/first out basis by the Executive Director of KMCB. The Solid Waste District will have the final decision as to eligibility of applicant and the award of services. Emergency application requests will be evaluated by the Manager of the Montgomery County Solid Waste District or his designee.*

### **Exclusions**

*The following are excluded from this program:*

- *Tires*
- *Hazardous Waste*
- *Housing or Building Demolition Debris*
- *Standard Bulk Waste from Residential or Commercial Property*
- *Any Commercial/Industrial Waste*
- *Sole Source Separated Yard Waste*

## **Montgomery County Solid Waste District Community Cleanup Program**

### **Eligibility:**

*The services from this program are available on a competitive basis within Montgomery County (see list of eligible groups below).*

*Eligible groups include (all services provided must be in Montgomery County):*

- *Municipal Jurisdictions within Montgomery County.*
- *Park Districts and Health Districts within Montgomery County.*
- *Political Subdivisions of the State of Ohio located in Montgomery County.*
- *Volunteer groups conducting litter and/or illegal dump cleanups.*
- *Volunteer groups conducting litter and/or illegal dump cleanups through the United Way Volunteer Connection program (program services must be used on the litter cleanup).*
- *Hardship cases referred by local municipal jurisdiction or Health Districts.*
- *Montgomery County Non-Profits, must be 501(c)3.*

### **Rating Criteria**

- *Need*
- *Multi agency partnerships.*
- *If illegal dump – ability to monitor or secure to prevent further dumping.*

### **Award Decisions**

*Applicants will be notified by email unless otherwise requested and will be requested to verify delivery and pickup information.*

### **Services by year**

*Total services for the program will not exceed 500 tons per year.*

### **Accountability & Reporting Requirements**

***Recipients** – Submission of the Cleanup Summary Report presently used for KMCB programs within seven days of completion of project. Before and after pictures must be submitted.*
