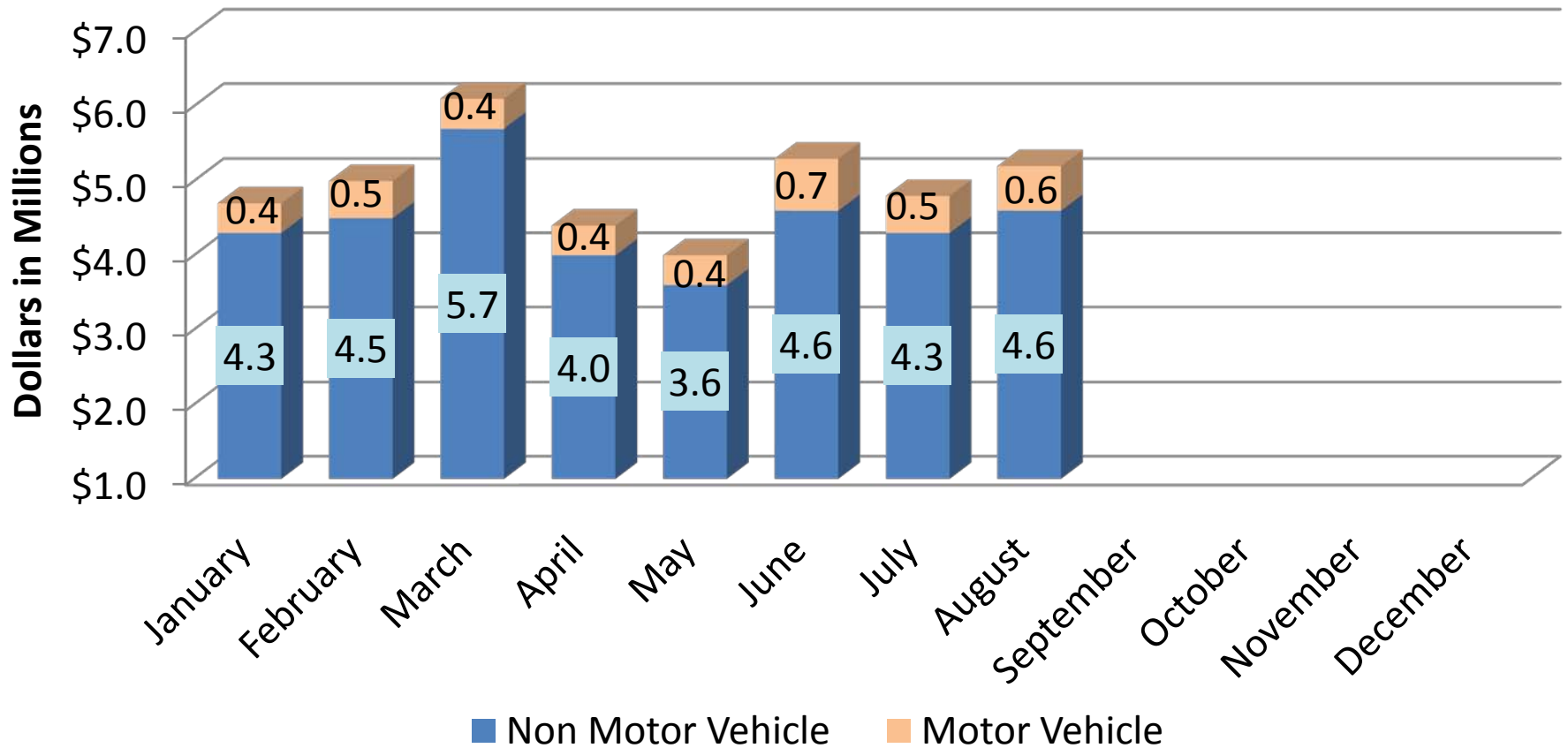

Notes:

1. August 2010 receipts reflects sales from May 2010.
2. Under August 2010 receipts, five weeks of motor vehicle distributions were reported. Five weeks were reported in 2009.
3. The sales tax base was expanded in October 2009 (January 2010) to include managed care (medicaid) programs.
4. Sales tax decrease for motor vehicles was \$9,646 and non-motor vehicle sales taxes increased \$243,406 from 2009.
5. Due to vendor overpayment on purchases that were not taxable from July 2001 through April 2005, an audit was conducted and a refund was made in February 2007. The impact to Montgomery County was a reduction of \$915,351 for April 2007. If the reduction had not taken place, April 2008 would have increased only \$198,974 or 4.2% for a total 2008 year-to-date decrease of \$27,890 or 0.0%
