Guardian Education

For Family Members

As the guardian of an adult family member, you are required to complete Guardian Education classes for the first three years of the guardianship. In the first year, you are required to complete a 6 hour Fundamentals class. In the second and third years, you are required to complete 3 hour Continuing Education classes.
