Fees in general; See ORC Sec. 317.32, 317.36 A table of fees is to be posted in the Recorder's Office. Sec. 2335.30 Recorder shall collect fees prescribed by law and shall give an official receipt. Sec. 325.28

Fees are not to be remitted nor collected other than prescribed. Sec. 325.36 Fees are to be endorsed on instrument. Sec. 317.26 Itemized bill must be furnished if demanded. Sec. 2335.32

There shall be no reduction, abatement or remission of fees, costs. Sec. 325.32 The Recorder shall collect no fees from the county. Sec. 325.31(C) Recorder shall pay into the general fund all fees collected. Sec. 325.31

Accounts are to be kept of fees charged and collected; accounts belong to county and are to be open to inspection. Sec. 325.30 Fees, costs, percentages, etc., are to be for use of county. Sec. 325.27

For specific information about documents the fee to be charged and/or revision of fees consult the Ohio Revised Code.
