## Group Tour Guidelines Montgomery County Environmental Services

**Please review this information carefully before the day of your tour.**

### Locations Available to Tour:

- Environmental Lab** 4257 Dryden Rd. Moraine, OH 45439
- Western Regional Wastewater Treatment Facility** 4111 Hydraulic Rd. West Carrollton, OH 45449
- Eastern Regional Wastewater Treatment Facility** 1802 Spaulding Rd. Kettering, OH 45432

**Cancellations and Changes:** Please notify Montgomery County Environmental Services (MCES) if you must cancel, reschedule a tour or if your group size changes. This allows other groups the opportunity to schedule, and helps MCES adjust schedules, parking needs and room reservations.

### What to Expect:

- The Environmental Lab** performs a variety of water and wastewater quality testing for Montgomery County Environmental Services, other water and wastewater systems, government agencies, and residential home-owners. Tours will see a variety of analytical testing.

**Our two Wastewater Treatment Facilities** treat approximately 23 million gallons of sewage every day through a large, multi-step process. Each treatment facility offers different treatment processes to meet permit limits.

- Tours will see first-hand the process of treating raw sewage from start to finish.**

**Transportation and Parking:** Parking is limited and carpooling is encouraged. Buses are encouraged to drop off and load students at the front entrance of the facility.

**Safety:** The **Eastern Regional Wastewater Treatment Facility** and **Western Regional Wastewater Treatment** are industrial environments. The **Environmental Lab** is a standard laboratory environment, but does contain some industrial elements. Please be sure to abide by all posted warning signs and the instructions of the tour guide(s). Visitors are not permitted to enter restricted areas of the facility or any area not permitted by the tour guide. Any provided safety attire, including, but not limited to, ear protection, eye protection, and high visibility vest must remain on at all times during the tour. All tour participants must wear closed-toed shoes. Please note: none of the facilities are ADA compliant, there are stairs and walking required.

**Photos and Video:** Photos and video are permitted during the tour. Photos taken by MCES staff may be used in future MCES publications, on the MCES website or in other promotional materials, including Social Media.
