ArriveSafe Gives Hundreds of Free Cab Rides “Award of Excellence” presented by MADD

According to the National Highway Transportation Safety Administration, in 2006 there were 1.5 million people arrested in the United States for drunk driving. Some 41% of all traffic fatalities were alcohol related, resulting in 17,602 deaths. The statistics for Montgomery County closely mirror those of the rest of the nation. In 2006, there were 49 traffic fatalities, 21 of which (or 43%) were alcohol related. For comparison, in 2005 there were 59 traffic fatalities, 23 of which (or 39%) were alcohol related. While the number of fatalities is down from 2005, the percentage of alcohol related fatalities is higher.

Armed with this information, Prosecutor Mat Heck was determined to combat this problem. After researching what other communities and civic groups did to combat drunk driving, the project known as *ArriveSafe* was conceived.

ArriveSafe was announced during a press conference on December 19, 2007. The program, sponsored by the Prosecutor's Office, AAA Miami Valley and the Southwest Ohio Affiliate of MADD, would pay up to \$50 towards a cab ride for any Montgomery County resident that felt they were too impaired to drive home. The program ran on two consecutive weekends, being the Friday-Monday before Christmas and before New Years Day.

Residents requesting a ride called 449-9999 and an operator would get the pertinent

information and relay it to Miami Liberty Cab Company of Dayton, who provided the cabs.

Over the eight days the program was active, some 366 cab rides were given.

ArriveSafe was again offered over the St. Patrick's Day weekend. Over the four days the program was offered, 100 cab rides were given.

Prosecutor Heck said, "While we can never know how many injuries or deaths may have been prevented by *ArriveSafe*, keeping over 450 impaired drivers from driving on the streets of our community can only have had a positive impact."

On March 18, 2008 Prosecutor Heck received an Award of Excellence from the Southwest Ohio Affiliate of Mothers Against Drunk Driving (MADD). Given during an award luncheon in Loveland, Mat Heck was recognized for his contribution to the goals of MADD by offering the *ArriveSafe* program. In addition to *ArriveSafe*, the annual Homicide Victim's Memorial Service was also recognized by MADD. The service, now in it's 18th year, recognizes those Montgomery County citizens who lose their lives to violence each year. Among those recognized are those killed by drunk drivers.

With the success of *ArriveSafe* during the Christmas, New Year's and St. Patrick's Day weekends, it most assuredly will be offered in the future .

Mat Heck, Jr. Selected As Ohio's Outstanding Prosecutor Of The Year

The Ohio Prosecuting Attorneys Association (OPAA) selected county prosecutor Mat Heck, Jr. the 2007 "Outstanding Prosecuting Attorney of the Year". Prosecutor Heck received this award at the OPAA Awards Banquet held at the Ohio State Capital in Columbus on November 29, 2007.

Each year, all county prosecutors in Ohio are invited to nominate their peers for this award. A committee of prosecuting attorneys then reviews the nominations to choose the prosecutor they wish to honor whose accomplishments have earned them the highest degree of respect in the field of prosecution.

This year, Mr. Heck was nominated and selected for his overall contribution and lifetime commitment of service to the effective prosecution of criminals, and holding those who victimize others responsible for their actions.

Prosecutor Heck said, "I am truly grateful and humbled by this recognition. There is nothing more rewarding or meaningful than being honored by one's peers, by the persons who do the same job as I do every day."

Assistant Prosecutor Mary Montgomery Named As Criminal Trial Team Leader

Mary Montgomery was promoted to Criminal Trial Team Leader on February 25. Trial Team Leaders supervise the Assistant Prosecutors handling Criminal Dockets in Common Pleas Court.

Ms. Montgomery joined the staff full-time in 1998. Since March, 2007, she has been the Supervising Attorney of the Intake and Grand Jury Division.

Assistant Prosecutor Kim Melnick Named As Supervising Attorney Intake and Grand Jury Division



The W.I.S.E. Program, which stands for **Webbie's Internet Safety Education Program**, was launched on March 13, 2008 at a press conference given by Prosecutor Mat Heck, Jr. and Assistant Prosecutor Johnna Shia.

The W.I.S.E. Program, and its mascot, 'Webbie' are designed to empower youth and to educate parents and teachers to the risks involved with internet use.



The internet is a great resource for information. But it can also be a very dangerous place for our children. Predators use this tool to get to our children every day. Predators are very patient, they will find a vulnerable child and spend time "grooming" them and earning their trust with gifts and a sense of understanding, sometimes exposing them to pornography for

approval, then they will arrange to meet our children in person. We see a lot of this, right here in Montgomery County.

The W.I.S.E. Program is a new and exciting initiative that offers materials for parents, educators, teens and children including safety tips on a convenient mouse pad, Montgomery County stories, how to recognize tactics used by a predator, cyber bullying, the lingo, and much more.

Operation *Bite Back* Update

On June 12, 2007, the Montgomery County Grand Jury indicted 38 defendants on dog fighting charges as a result of a 14 month long investigation, Operation Bite Back. Undercover agents attended dog fights in Montgomery County between April 2006 and March 2007, at six locations.

There were two additional dog fighting cases indicted on November 11, 2006 that were not a part of Operation Bite Back, involving five defendants. In those cases, a total of 71 dogs were confiscated.

In the 16 months since November 2006, a total of 43 individuals have been indicted on charges of dog fighting. As of this writing, 39 of those defendants have been convicted, one defendant has an outstanding warrant, two are pending cases, and one defendant is deceased.

Buyer Beware When Buying Gift Cards Online

One of the newest scams to hit consumers is the online sale of store gift cards. On some online auction sites and online gift card 'stores', gift cards from major retailers are being sold at a discount. An example is a recent listing of a \$200 gift card to Wal-Mart that sold at auction for \$135. The card was obtained by the seller fraudulently, and was not honored by Wal-Mart.

The scam is referred to as "cyber money laundering". Often times, the crook uses stolen credit card numbers to quickly make large purchases of gift cards which are sold over a long period of time to unsuspecting buyers.
