## Sentencings

In November, 2019, we disposed of 302 cases. The Judges sentenced the defendants in those cases as follows:

- 50.3% received Community Control Sanctions (probation)
- 18.9% were sentenced to the penitentiary
- 24.8% were granted Intervention in Lieu of Conviction (ILC)
- 6.0% received local jail time, or local jail time plus probation

Some notable sentences:

- 10/15/2019 - **James Davison** was sentenced to 48 years-to-life in prison after being convicted of one count of aggravated murder, one count of murder, two counts of felonious assault, one count each of discharge of a firearm at or near prohibited premises, improper handling of a firearm in a motor vehicle, and tampering with evidence. On April 21, 2018, the defendant left Rick's Jazz Club on Lakewood Avenue in Dayton. He drove through the lot, stopping with his driver's side door next to the driver's side door of a truck containing four occupants. The defendant then fired nearly two dozen rounds from a .40 caliber handgun into the truck, killing the driver and front seat passenger. Mr. Dan Brandt, Mr. John Amos, and Ms. Nicole Amrhein were the assistant prosecutors on the case.

The Advocates specialize in cases of sexual assault/abuse and homicide. However, they offer a variety of services to other victims and witnesses as well. The goal of the division is to help victims and witnesses understand their rights and responsibilities.


