2016—The Year In Review

Every division of our office was very busy again the past year. During 2016, assistant prosecutors in the Criminal Division reviewed 5,660 felony cases presented to our office by area law enforcement agencies. This is an increase over 2015 of approximately 4%. The Juvenile Division reviewed 1,715 criminal filings, a slight decrease from 2015's 1,760 filings.

Heroin continues to be an ongoing problem in our community, and heroin overdose deaths continue to be a growing problem. Tragically, 2016 had a record number of overdose deaths in Montgomery County.

Montgomery County also experienced an increase in the number of homicides in 2016. After three years with the homicide rate being flat, there was suddenly a 34% jump in 2016. Hopefully this was just a single-year anomaly.

Shockingly, our office also had a 70% increase in the number of indictments for rape in 2016, as well as a slight increase in indictments for felony domestic violence from 2015. One bright spot is that the number of robbery and burglary indictments continued their downward trend - 2016 had approximately 20% fewer cases indicted than in 2012.

In 2017 and beyond, we will continue to work cooperatively with our partners in the law enforcement and criminal justice community in order to make Montgomery County a safe place to live, work, and play.

Prosecutor Heck Sworn In For 7th Full Term of Office

On January 3, 2017, Prosecutor Mat Heck, Jr. was sworn in for his seventh full term of office. The Honorable Daniel G. Gehres, Judge of the Dayton Municipal Court, administered the Oath of Office. Following his swearing in, Prosecutor Heck then administered the Oath of Office to his staff.

After the ceremony, Prosecutor Heck highlighted and gave an overview of the past four years. The Criminal Division of the Prosecutor's Office reviewed nearly 22,000 felony cases that were presented for charges by 36 law enforcement agencies. Over 11,500 felony cases were prosecuted, with 87% of them resulting in a conviction of the highest indicted charge. Over the past four years, the attorneys assigned to felony criminal trial dockets had 260 jury trials and 100 bench trials.

The Child Abuse Bureau, located at Montgomery County's Child Advocacy Center, CARE House, has assistant prosecutors and victim advocates who specialize in cases involving child physical and sexual abuse. The prosecutors and advocates there handled over 200 felony child abuse cases.

The Juvenile Division of the office handled over 160 cases of juvenile sexting. Most of those teens were accepted into our Sexting Diversion Program, believed to be one of the first such programs in the nation. The Delinquency Section of the Juvenile Division reviewed nearly 7,500 cases, resulting in over 6,500 cases being accepted for prosecution.

The Victim/Witness Division of the office trained over 100 volunteers to assist our advocates in providing crisis response services 24-hours-per-day, every day of the year to crime victims, especially those of violent crimes. During the past four years, the division provided services to thousands of clients, including approximately 3,200 victims of domestic violence, and 2,500 victims of sexual assault.

The Diversion Program returned nearly \$1,000,000 in restitution to the victims of crime, while also restoring first-time, non-violent offenders to productive, law-abiding citizens. The Criminal Non-Support section of Diversion, where the goal is and has always been to hold parents financially responsible for their children instead of being placed in jail, collected over \$110,000 in court-ordered child support owed by non-custodial parents. This program continues to succeed in those cases where civil enforcement has not.

Our Civil Division provides legal advice and representation to other county elected officials, commissions, boards, and townships. The issues we deal with are varied and include everything from property acquisitions, personal injury, to personnel matters. Over the past four years, the Civil Division was expanded to respond to an unusually large number of public record requests and to handle an increase in the number of complex litigation suits filed against the county in federal, state, and county courts.

Prosecutor Heck finished his remarks, stating, "During my first swearing in, I stated that it is my firm belief that working together we can make a difference. My beliefs have not waived - we have made a difference in the lives of those we work for. I am honored and truly appreciate to be re-elected your Prosecuting Attorney for another four years. I look forward to pursuing and implementing solutions to the problems the future may bring."

2016 - The Year In Review

The Criminal Division Cases

The Criminal Division of the office is the division of the office most people think of when talking about a prosecutor's office. 2016 was a busy year for the Assistant Prosecutors assigned to Felony Criminal dockets. Below is a short listing of some of the most significant, important, or tragic cases prosecuted to conviction by our office this past year:

January 15, 2016—**Mark Anthony Derrick**, 55, convicted of felonious assault, aggravated robbery, and domestic violence, was sentenced to 14 years in in prison. The defendant shot his wife in the head inside her home after a domestic argument on January 5, 2015. The defendant is incarcerated at Pickaway Correctional, with an expected release date of January 1, 2029. (Case# 2015-CR-0081)

January 21, 2016—**Anthony Shawn Edwards**, 36, convicted of three counts of aggravated robbery with repeat violent offender specifications, was sentenced to 12 years in prison. The defendant robbed three businesses on Linden Avenue in Dayton between September and October of 2015. He had previously been convicted of two other robberies and three burglaries and was on parole at the time of these new offenses. The defendant is incarcerated at Ross Correctional, with an expected release date of October 25, 2027. (Case# 2015-CR-3334)

February 3, 2016—**John M. Cochran**, 32, convicted of murder, felonious assault, and disrupting public services, was sentenced to 15 years to life in prison. On May 28, 2014, the defendant fatally beat and stabbed his roommate, 52-year-old Mark Gershon, inside their Englewood residence. The defendant is incarcerated at Noble Correctional, and will not be eligible for consideration of parole until April, 2029. (Case# 2014-CR-1930)

February 25, 2016—**Harley Farrell**, 25, and **Darryl Ferguson**, 19, convicted of the beating death of 35-year-old Ryan Adams, were both sentenced to 11 years in prison. The defendants got into a fight with the victim on Deeds Avenue in Dayton on June 8, 2014. Defendant Farrell is incarcerated at Lebanon Correctional, with an expected release date of June 6, 2025. Defendant Ferguson is incarcerated at Noble Correctional, with an expected release date of June 4, 2025. (Case# 2014-CR-2059)

February 25, 2016—**Phillip Tyra**, 21, convicted of murder, felonious assault, aggravated robbery, carrying concealed weapons, and trafficking in marijuana, was sentenced to 20 1/2 years to life in prison. On May 27, 2015, the defendant shot and killed the victim, Triston McDonald, during a drug transaction. Forensic evidence indicates the victim was shot four times, including a shot to the back of the head. The defendant is incarcerated at Warren Correctional, with an expected release date of November 29, 2035. (Case# 2015-CR-1681)

March 7, 2016—**Ronald Winton, Jr.**, 55, convicted of murder and felonious assault, was sentenced to 15 years to life in prison. The defendant strangled Tasha Bonner to death on February 2, 2014. Police responded to the defendant's Woodward Avenue apartment after receiving calls about a man dragging a woman's body into his apartment. The defendant is incarcerated at Warren Correctional, and will not be eligible for consideration of parole until May, 2029. (Case# 2014-CR-2247)

March 10, 2016—**Rene Nevarez-Reyes**, 24, convicted of aggravated possession of drugs with a major drug offender specification, was sentenced to 11 years in prison. After a K-9 alerted to illegal drugs during a traffic stop, Deputies discovered approximately seven pounds of crystal methamphetamine hidden inside a compartment in the defendant's fuel tank. The defendant is incarcerated at Noble Correctional, with an expected release date of August 11, 2023. (Case# 2014-CR-3659)

March 24, 2016—**Carlos Craig**, 20, convicted of murder, aggravated robbery, felonious assault, and discharge of a firearm on or near prohibited premises, was sentenced to 18 years to life in prison. On July 7, 2015, the defendant fatally shot Damarcus Bures inside a vehicle on North Delmar Avenue. The defendant is incarcerated at Ross Correctional, and will not be eligible for consideration of parole until April, 2033. (Case# 2015-CR-2107/1)

March 31, 2016—**Dustin Rybak**, 28, convicted of involuntary manslaughter, endangering children, and tampering with evidence, was sentenced to 18 years in prison. The defendant caused the death of 19 month old Takota Hasty, who died on April 8, 2013 from blunt force trauma to his head and neck. The defendant died from a drug overdose on November 7, 2016 while in custody at the Montgomery County Jail. (Case# 2013-CR-1102/1)

April 7, 2016—**Sean Sorrentino**, 32, convicted of aggravated murder, aggravated burglary, burglary, and assault, was sentenced to life in prison with a possibility of parole after 20 years. On June 2, 2015, the defendant fatally stabbed Allen Samuels inside the victim's Kettering apartment. The defendant is incarcerated at Warren Correctional, and will not be eligible for consideration of parole until April 2035. (Case# 2015-CR-1615)

April 11, 2016—**Theodore Satterwhite**, 24, convicted of involuntary manslaughter and felonious assault, was sentenced to six years in prison. On November 3, 2005, Roscoe Shipp was fatally shot outside JP's Bar and Grill on North Gettysburg Avenue. The Dayton Police Department's Cold Case Homicide Unit identified the defendant. The defendant is currently incarcerated at Gilmer Federal Correctional Institution in Glenville, West Virginia, on unrelated charges with an expected release date of May 7, 2021. (Case# 2014-CR-4075)

April 12, 2016—**Eleazar Flores Lopez**, 38, convicted of aggravated possession of drugs with a major drug offender specification, was sentenced to 11 years in prison. On October 8, 2014, after a K-9 alerted to illegal drugs during a traffic stop, officers discovered over eight pounds of methamphetamine in the vehicle. The defendant was in the U.S. illegally. The defendant is incarcerated at Chillicothe Correctional, with an expected release date of July 24, 2023. (Case# 2014-CR-3487/1)

April 15, 2016—**Justin Payne**, 28, convicted of involuntary manslaughter, endangering children, and tampering with evidence, was sentenced to 16 years in prison. On August 8, 2015, the defendant reported to police that the victim, two year old Jacob Barker, had choked on a pop-tart. An autopsy determined the child died from blunt force trauma to his head. The defendant is incarcerated at Chillicothe Correctional, with an expected release date of August 4, 2031. (Case# 2015-CR-2449)

April 15, 2016—**Jamie Tuck**, 45, convicted of aggravated murder, aggravated robbery, felonious assault, and kidnapping, was sentenced to life without the possibility of parole. On or about June 8, 2015, the defendant brutally stabbed and cut his mother inside her home and took some of her belongings. The defendant is incarcerated at Warren Correctional. (Case# 2015-CR-1724)

April 28, 2016—**Tanner Hopkins**, 26, convicted of murder, involuntary manslaughter, reckless homicide, and felonious assault, was sentenced to 46 years to life in prison. On January 13, 2015 the defendant beat his girlfriend, causing the death of their unborn child. The defendant is incarcerated at the Lebanon Correctional, and will not be eligible for consideration of parole until September 15, 2060. (Case# 2015-CR-0121)

May 6, 2016—**Crystal Laurel**, 28, convicted of involuntary manslaughter, permitting child abuse, endangering children, and tampering with evidence, was sentenced to six years in prison. The defendant was convicted for her part in causing the death of her 19 month old son, Takota Hasty, who died on April 8, 2013 from blunt force trauma to his head and neck. The defendant is incarcerated at Dayton Correctional, with an expected release date of April 4, 2019. (Case 2013-CR-1102/2)

May 27, 2016—**Angela Burnham**, 41, convicted of aggravated theft of \$150,000, money laundering, and forgery, was sentenced to probation, over the objections of the prosecutor's office and the victim, the Lions Eye Bank of West Central Ohio. The defendant was the executive director of the non-profit, and she stole \$671,661 from the charity. (Case# 2015-CR-1263)

May 31, 2016—**Scott Gray**, 38, convicted of vehicular homicide and failure to stop after an accident, was sentenced to four years in prison. The defendant was driving 101 mph in a 35 mph construction zone on South Dixie Drive in Vandalia when he struck another vehicle, killing 37 year old Melissa Carlson, and injuring three others. The defendant is incarcerated at Madison Correctional, with an expected release date of August 6, 2019. (Case# 2015-CR-3454)

June 9, 2016—**Tabaree Shabazz**, 43, convicted of murder with a repeat violent offender specification, and felonious assault, was sentenced to 25 years to life in prison. The defendant killed his girlfriend, Shelia Gibson, by blunt force trauma to her head on or about July 12, 2014. The defendant is incarcerated at Lebanon Correctional, and will not be eligible for consideration of parole until December, 2039. (Case# 2014-CR-3732)

June 9, 2016—**Kimiko Hardy**, 39, convicted of involuntary manslaughter, endangering children, and failure to confine or restrain a vicious dog, was sentenced to three years in prison. The defendant's seven month old step-grandson, Jonathan Quarles, Jr., was attacked and killed by the defendant's pit bull mix dog on July 20, 2014, after previous dog bite incidents by this same dog. The defendant is incarcerated at the Ohio Reformatory for Women, with an expected release date of June 5, 2019. (Case# 2015-CR-1185)

June 15, 2016—**Dominique Mays**, 25, convicted of involuntary manslaughter, felonious assault, abduction, tampering with evidence, gross abuse of a corpse, and domestic violence, was sentenced to 20 years in prison. Amber Owens' body was discovered by road crews along Post Town Road in Trotwood on December 4, 2014. The victim had been missing since October 21, 2014. The defendant is incarcerated at Mansfield Correctional, with an expected release date of July 22, 2035. (Case# 2015-CR-1101)

June 27, 2016—**Dionte Evans**, 24, convicted of murder, involuntary manslaughter, and endangering children, was sentenced to 15 years to life in prison. The defendant was responsible for causing the death of his girlfriend's 21 month old son, Keyontae Ellis-Bell, on April 8, 2015. An autopsy determined the child died from blunt force trauma. The defendant is incarcerated at Ross Correctional, and will not be eligible for consideration of parole until February, 2030. (Case# 2015-CR-1084)

June 30, 2016—**Nickolai Gray, Jr.**, 21, convicted of felonious assault, discharge of a firearm on or near prohibited premises, and having weapons while under disability, was sentenced to seven years in prison. On December 24, 2015, the defendant fired a gun at a vehicle on Blueberry Avenue in Dayton, striking a two year old passenger. The defendant is currently incarcerated at Southeastern Correctional, with an expected release date of December 26, 2022. (Case# 2015-CR-3999)

July 11, 2016—**Michael Martin**, 59, convicted of murder, felonious assault, discharge of a firearm on or near prohibited premises, and improper handling of a firearm in a motor vehicle, was sentenced to 30 years to life in prison. On March 26, 2016 the defendant shot through the open sunroof of his vehicle, striking Gary Tisdale who was standing outside the vehicle. The shooting victim then got into his own vehicle and drove away, only to crash into a tree on James H. McGee. He was pronounced dead at the scene. The defendant is incarcerated at Warren Correctional, and will not be eligible for consideration of parole until February, 2046. (Case 2016-CR-0977)

July 22, 2016—**Anthony Demar Smith**, 28, convicted of 11 counts of intimidation and eight counts of intimidation of an attorney, was sentenced to 12 years in prison. The defendant is currently serving a life sentence for his prior convictions on rape of a child under 13 and unlawful sexual conduct with a minor. In December 2014, the defendant sent a letter to an assistant prosecutor listing a number of judges and assistant prosecutors who would be "targeted." The 12 year sentence was ordered to be served consecutively to his life sentence. The defendant is currently incarcerated at Southern Ohio Correctional, and will not be eligible for consideration of parole until April, 2032. (Case# 2015-CR-0796)

July 29, 2016—**Markus Henry**, 32, convicted of aggravated murder and murder, was sentenced to 35 years to life in prison. The defendant was convicted of the April 16, 2010 murder of Reas Lee, who had been stabbed to death, for which he was sentenced to 15 years to life, and the December 7, 2011 shooting death of Sheila Tucker, for which he was sentenced to 20 years to life. The sentences were ordered to be served consecutively. The defendant is currently incarcerated at Southern Ohio Correctional, and will not be eligible for consideration of parole until February, 2050. (Case# 2014-CR-3990 and 2015-CR-3930)

August 3, 2016—**Earl Simone**, 76, convicted of aggravated theft over \$1,500,000, was sentenced to five years in prison and was ordered to pay \$1,900,000 in restitution. The defendant was formerly the Pastor at St. Peter Catholic Church in Huber Heights. Over the years, the defendant misappropriated church funds for his own use. The defendant is incarcerated at the Corrections Medical Center, with an expected release date of August 2, 2020. (Case# 2015-CR-3730)

August 8, 2016—**Joshua Hackney**, 31, convicted of aggravated vehicular homicide, and aggravated vehicular assault, was sentenced to three years in prison. The defendant caused a head-on traffic crash on February 22, 2016 that killed the passenger in the other vehicle, 74 year old Kathleen Kidwell, and seriously injured the driver. The defendant had heroin in his system at the time of the crash, as well as a suspended driver's license. The defendant is incarcerated at Southeastern Correctional, with an expected release date of July 20, 2019. (Case# 2016-CR-1232)

August 31, 2016—**Linda Baccus**, 62, convicted of involuntary manslaughter, was sentenced to five years in prison. In November, 2015, the defendant confessed that she had caused the beating death of her father, Sanders Baccus, in January, 1987, in Dayton. The defendant is incarcerated at the Ohio Reformatory for Women, with an expected release date of August 30, 2021. (Case# 2015-CR-3754)

September 2, 2016—**Jonathan Boehme, Jr.**, 33, convicted of rape of a child under 13 and gross sexual imposition, was sentenced to 11-and-a-half years in prison. Between 2012 and 2015, the defendant raped a pre-teen child multiple times at a home in Brookville. The defendant was designated a Tier III sex offender, requiring that he register his address with authorities every 90 days for the rest of his life. The defendant is incarcerated at the London Correctional, with an expected release date of October 18, 2026. (Case# 2015-CR-1221)

September 2, 2016—**Michael Scott**, 21, convicted of murder, felonious assault, having weapons while under disability, and illegal possession of a firearm in a liquor permit premises, was sentenced to 22 years to life in prison. On September 27, 2015, at Cricket's Tavern in Huber Heights, an altercation occurred and eyewitnesses reported seeing the victim, Joshua Hamilton, being beaten and assaulted before being shot by the defendant. The defendant is incarcerated at Warren Correctional, and will not be eligible for consideration of parole until August, 2037. (Case# 2015-CR-3057)

October 11, 2016—**Dwight Gehring**, 67, convicted of rape and gross sexual imposition, was sentenced to 13 years in prison. The defendant, a licensed massage therapist in Englewood, sexually assaulted a five year old child. The assault was captured on a home security surveillance system. The defendant is incarcerated at Madison Correctional, with an expected release date of May 13, 2028. (Case# 2015-CR-1470)

October 24, 2016—**Harvey Jones**, 38, convicted of aggravated murder, aggravated burglary, and aggravated robbery, was sentenced to two consecutive life terms without the possibility of parole, plus an additional, consecutive 52 years in prison. On January 24, 2013, the defendant fatally shot and killed 32 year old Carly Hughley and 29 year old Demetrius Beckwith inside an apartment in Harrison Township. The defendant had been out of prison for less than a year, after serving nearly 10 years in prison for aggravated burglary and attempted rape. The defendant is incarcerated at Warren Correctional. (Case# 2013-CR-0294)

October 27, 2016—**Jose Menchu**, 29, convicted of possession of cocaine over 100 grams and trafficking in cocaine over 100 grams, with major drug offender specifications, was sentenced to 11 years in prison. During a traffic stop, a K-9 indicated the presence of illegal drugs in the defendant's vehicle. A search of the vehicle and a subsequent search of the defendant's residence revealed over 100 grams of cocaine. The defendant is incarcerated at the Corrections Reception Center, with an expected release date of October 24, 2025. (Case# 2014-CR-3738)

October 27, 2016—**James Lane**, 31, convicted of attempted kidnapping, menacing by stalking, and violation of a protection order, was sentenced to eight years in prison. On March 16, 2016, the victim reported to police that the defendant, her estranged husband, was stalking her and had made plans to kidnap her. The defendant is incarcerated at North Central Correctional, with an expected release date of March 13, 2024. (Case# 2016-CR-0874)

November 16, 2016—**Jean Paul Mpanurwa**, 29, convicted of rape, kidnapping, and felonious assault, was sentenced to 13 years in prison. On July 14, 2013, the defendant, who is from the Republic of Congo and not a U.S. citizen, knocked the 90 year old victim to the ground, dragged her to a nearby grassy area, and raped her. The defendant is incarcerated at the Corrections Reception Center, with an expected release date of August 12, 2026. (Case# 2013-CR-2542)

November 29, 2016—**Jason Shontee**, 53, convicted of voluntary manslaughter with a repeat violent offender specification and having weapons while under disability, was sentenced to 21 years in prison. On June 13, 2016, the defendant fatally shot the victim, Robert Hildebrand, inside an apartment building on Smithville Road in Dayton. The victim, who also served as the building caretaker, had learned the defendant was storing stolen items in the building and had locked him out. The defendant is incarcerated at the Corrections Reception Center, with an expected release date of June 8, 2037. (Case# 2016-CR-1878)

December 5, 2016—**Kyndra Shackelford**, 19, convicted of aggravated vehicular homicide, aggravated vehicular assault, failure to comply with the order or signal of a police officer, and grand theft motor vehicle, was sentenced to 16 years and three months in prison, and received a lifetime suspension of her driver's license. On March 17, 2016, a Huber Heights police officer spotted a vehicle driving erratically that had been reported stolen from Butler Township. When the officer attempted a traffic stop, the defendant drove off at a high rate of speed, eventually running a red light at Wagner Ford Road at Needmore Road, striking another vehicle. The crash killed the driver of that vehicle, Marcus Harper, and severely injured his passenger. The defendant is incarcerated at the Ohio Reformatory for Women, with an expected release date of March 27, 2029. (Case# 2016-CR-0883)

December 15, 2016—**Elyssa Davis**, 33, convicted of involuntary manslaughter and corrupting another with drugs, was sentenced to two years in prison. On November 2, 2015, the victim's friend called police after finding the victim's dead body inside his home on Old Springfield Road in Butler Township. The victim, Kelly Vogler, had died of an overdose of Fentanyl, Alprazolam, and ethanol, that the defendant had injected into him. The defendant is incarcerated at the Ohio Reformatory for Women, with an expected release date of November 8, 2017. (Case# 2016-CR-0800)

ArriveSafe Program to Offer Free Rides for St. Patrick's Day

After seeing case after case of injuries and deaths being committed by drunk drivers, Prosecuting Attorney Mat Heck, Jr. decided in late 2007 to do something proactive about the problem. Prosecutor Heck began the ArriveSafe initiative as a result. ArriveSafe offers free cab rides home for Montgomery County residents over major holidays.

Since 2007, the program has provided well over 5,700 free cab rides, all at no cost to the taxpayer. The funds for the program come from money seized by the prosecutor's office (primarily from drug dealers) and from donations from our partners, AAA Miami Valley and Heidelberg Distributing Company.

The program works like this: the Montgomery County resident calls 449-9999, which goes to an answering service, and requests a free cab ride home. The answering service takes the callers name and phone number, as well as the pick-up and drop-off addresses. The drop-off address must be a residence within the county. The answering service then contacts one of the many cab companies we have partnered with and relays the information. Once the cab has safely delivered the resident to their home, the cab company makes a record of the delivery and bills our office directly. We pay up to \$50.00 for the cab fare, which covers riders from one end of the county to the other.

This upcoming St. Patrick's Day weekend, make the smart decision to not get behind the wheel if you are drinking alcohol or otherwise impaired. As Prosecutor Heck says, "The life you save may be your own!"
